Additional Tank Mix Partners for Bellum Herbicide applied Postemergence in Corn

Stalwart® C Vail CRN Visor CRN Visor S-MOC Visor S-MOC II Solo metolachlor products	Regarding tank mix adjuvants, it is recommended to use non-nitrogen based products; or if using nitrogen based products (like UAN or AMS) apply as a post-directed spray to limit contact with crop foliage.
Stalwart® Xtra Stalwart® Xtra Lite Visor S-MOC ATZ Metolachlor + Atrazine premix products	To minimize risk of crop injury, the user may use nonionic surfactants (NIS) instead of the crop oil concentrates (COC).
Solo acetochlor products Acetochlor + Atrazine premix products	Control of emerged weeds can be reduced due to substandard adjuvant effect or poor weed coverage.
