MATRIX[®] SG Herbicide applied at the rate of 4.0 oz product (0.0625 lb ai) per acre can be tank mixed with Goal[®] 2XL (AI: oxyfluorfen, Reg No. 62719-424) at 3.0 to 6.0 pints (0.75 – 1.5 lb ai) per acre, or GoalTender[®] herbicide (AI: oxyfluorfen, Reg. No. 62719-447) at 1.5 to 3.0 pints (0.75 – 1.5 lb ai) per acre, or “Chateau SW” herbicide (AI: flumioxazin, EPA Reg No. 59639-99) at 6.0 to 12.0 ounces (0.2 – 0.4 lb ai) per acre, to help improve overall weed control in citrus, grapes, pome fruits, stone fruits and tree nuts. For best results incorporate mechanically via light tillage or with 1/2” irrigation following application.

It is important to use a postemergence/contact herbicide including glyphosate or other registered postemergence herbicides to control any emerged weeds in order to obtain the best residual weed control from MATRIX[®] SG Herbicide.

It is the pesticide user’s responsibility to ensure that all product are registered for the intended use. Read and follow the applicable restrictions and limitations and directions for use on all product labels involved in tank mixing. Users must follow the most restrictive directions for use and precautionary statements of each product in the tank mixture.

Read and follow all mixing instructions on the MATRIX[®] SG label.

- **Do not** apply more than 4.0 oz (0.0625 lb ai) MATRIX® SG Herbicide per year on a broadcast acre basis.
- When applied as a banded treatment (50% band or less), MATRIX® SG Herbicide may be applied twice per year.
- Allow a minimum of 30 days between applications of MATRIX® SG Herbicide.
- Weed control is limited to weeds on the MATRIX® SG Herbicide label.
