TO REGISTRANTS OF COMMERCIAL FERTILIZER PRODUCTS IN THE STATE OF UTAH

To assist registrants in completing application forms for the registration of Fertilizers/Soil Amendments, the following information is outlined.

I. **What must be registered.**

The Utah commercial Fertilizer Control Act requires that all fertilizers or soil amendments must be properly registered when being manufactured, delivered, distributed, sold, or offered for sale in the State of Utah. All registrations of fertilizers or soil amendments, and any other product defined as fertilizer in the State of Utah.

II. **How to apply for registration Fertilizer/Soil Amendment products.**

- A. The registration fee for each Fertilizer/Soil Amendment product is \$60.00
- B. The fee should accompany the enclosed application and be made payable to the Utah Department of Agriculture.
- C. A Product label is required for each Fertilizer/Soil Amendment registered. Instructions below.
- D. All registrations expire December 31st each year, and renewals not paid by that date shall be subject to a penalty of \$25.00 per registered item.

III. **Custom-Formula Blenders License.**

Custom-formula fertilizer/soil amendments are exempt from registration, but custom-formula fertilizer/soil amendment mixers must obtain a license according to Utah law. Only manufacturers who formulate fertilizer/soil amendments to the specific direction of the final purchaser qualify for a custom-formula mix license. Also known as a blenders license. The blenders license fee is \$75.00 per application. Each location requires a separate application. If your manufacturing operation meets these requirements, an application for this license may be obtained from the Department of Agriculture upon request.

IV. **For your information**

All registrations expire on December 31 each year. Renewals not paid by that date shall be subject to a penalty of \$25.00 per registered product. New products are not considered as a late registration.

Your cooperation with the above items will expedite the registration of your product(s) and allow the Department to better serve you and the consumers of your products.
