Background: In the 2024 General Session, Rep. Jennifer Dailey-Provost sponsored <u>H.B.</u> 525 Agricultural Amendments which directed UDAF to study barriers and gaps related to increasing the availability of local food in the state and to report findings and recommendations to the Natural Resources, Agriculture, and Environment Interim Committee. Potential areas of focus included:

- i. the intra-state food supply chain;
- ii. alternative and specialty crop production, including comparing the production value of alternative crop types and the economic impact to the state and to producers and the natural resource, infrastructure, and financial implications associated with changing from animal-feed crops to direct-to-consumer crops;

- the agricultural workforce researching barriers to entry associated with careers in agriculture by reviewing current challenges, available resources, programs in other states that support individuals interested in pursuing careers in agriculture, and opportunities for new agricultural producers to use the expertise of existing agricultural producers and the potential for creating a small farm incubator program;
- iv. researching gaps in the state's food supply chain with respect to local food including aggregation, distribution, storage, refrigeration, and processing;
- v. and proposing potential funding solutions to address the issues identified by the department's research including recommendations for current state and federal money available, potential grant programs, and coordinating funding from state and federal sources.

The purpose of this discussion is to identify priorities, scope, roles and responsibilities for this and other future study items (legislative or otherwise).
