



### COMMUTER PERMIT for a BEEF BREEDING HERD

This agreement is for one pasture grazing season, for the cattle, duration, and premises described. Permits are issued on a case-by-case basis. Requests should be submitted to the Utah Department Agriculture and Food, Division of Animal Industry at least 14 days before the move.

A copy of the approved permit will be sent to the applicant.

**CONDITIONS of AGREEMENT**

**I understand and agree that:**

1. Cattle are from a valid beef breeding herd, established more than six months, moving for grazing purposes without change of ownership.
2. I will account for all animals on this agreement.
3. This agreement is subject to change if the risk of disease changes.
4. Failure to comply with the provisions of this agreement may result in the revocation of this permit and/or loss of use of any future pasture-to-pasture permits.
5. Cattle must return within 8 months.
6. All cattle must have official identification.
7. No trader or recently assembled cattle are in the origin herd of the animals moving.
8. All female cattle over 12 months of age entering or returning to Utah must be officially brucellosis vaccinated and bear a legible official brucellosis tattoo as evidence of the vaccination.
9. A brand certificate, certificate of veterinary inspection (CVI), and valid commuter permit are required for all cattle within the 30 days prior to entering the destination state. Cattle returning to Utah must meet the brand inspection requirements of the state they are grazing in.
10. Copies of the brand certificate, CVI and the Commuter Permit shall accompany each load or part of a shipment of cattle entering Utah.
11. All cattle included on this permit are to return to Utah. If planning to sell cattle in the state of destination they must move on a Certificate of Veterinary Inspection (health certificate) and meet all import requirements for the destination state.

**BRAND INSPECTION REQUIREMENTS REMAIN IN EFFECT**

**FOR CATTLE GRAZING IN IDAHO AND WYOMING ONLY**

**Wyoming DSA Testing Agreement:**

I agree to test no less than 100% of my female breeding age cattle (sexually intact female cattle 12 months of age and older) for brucellosis. I agree to test my cattle 30 days prior to leaving the DSA, or within 30 days following return to their premises of origin.

**Idaho DSA Testing Agreement:**

I agree to test no less than 20% of my breeding age cattle (sexually intact cattle 12 months of age and older) for brucellosis. The tested cattle will include all bulls and all open, late-bred, and dry cows and breeding-age heifers, and all cull cattle. Pregnant cows will make up the balance.

**Please agree to the following:**

I agree to send brucellosis test results to UDAF within 2 weeks of receipt. The cattle may not be turned out for grazing or commingled with other herds until the test results have been reported to UDAF.

I agree to officially identify all cattle with individual tags or official individual identification, regardless of age prior to entering the designated brucellosis surveillance area.

I agree to provide a copy of the brucellosis test results along with my commuter permit application for the following year.
