R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product.

1	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(a)	(1) Cannabis product labeling shall contain the following information: (a) the medicinal dosage form identified on the product face along with the words "THC or Cannabis Infused";
2	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(a)(i)	(1) Cannabis product labeling shall contain the following information: (a) the medicinal dosage form identified on the product face along with the words "THC or Cannabis Infused"; (i) "gummies" may be used instead of "gelatinous cube";
3	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(a)(ii)	(1) Cannabis product labeling shall contain the following information: (a) the medicinal dosage form identified on the product face along with the words "THC or Cannabis Infused"; (ii) "tincture" may be used instead of "sublingual preparation" or "liquid suspension";
4	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(a)(iii)	(1) Cannabis product labeling shall contain the following information: (a) the medicinal dosage form identified on the product face along with the words "THC or Cannabis Infused"; (iii) a descriptive product name, that is a common name for the dosage form, which is allowed if the text is smaller than the dosage form and the name is not appealing to children, recreational, or contain adjectives;
5	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(b)	(1) Cannabis product labeling shall contain the following information: (b) the name and license number of the cannabis processing facility;
6	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(c)	(1) Cannabis product labeling shall contain the following information: (c) directions for consumers to contact the department with product complaints by going to medicalcannabis.utah.gov/production ;
7	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(d)	(1) Cannabis product labeling shall contain the following information: (d) for products containing THC, a warning symbol provided by the department that contrasts conspicuously with the background;
8	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (1)(e)	(1) Cannabis product labeling shall contain the following information: (e) the amount of total THC contained in the package, in milligrams.
9	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (2)	A cannabis processing facility may include a QR code on the cannabis product labeling that links to a COA from a licensed independent cannabis testing laboratory. The QR code may not link to any other information.
10	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (3)(a)	Any information appearing on the cannabis product labeling shall be: (a) displayed in any legible font, that is not a script or decorative font, provided that the lowercase letter "o" is at least one-sixteenth inch in height;
11	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (3)(b)	Any information appearing on the cannabis product labeling shall be: (b) displayed in a color that contrasts conspicuously with its background; and
12	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (3)(c)	Any information appearing on the cannabis product labeling shall be: (c) displayed in English, although a licensee may also choose to display required information in additional languages.
13	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (4)	A cannabis processing facility shall place a cannabis fact panel on a cannabis product before the sale of the cannabis product to a medical cannabis pharmacy.
14	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (5)	The cannabis fact panel shall be printed in black and white.
15	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (6)	The cannabis fact panel shall be securely affixed to the package.
16	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (10)	A cannabis processing facility may include a QR code affixed to the product that is scannable for inventory control at the pharmacy. The QR code may not link to any other information.
17	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (11)	The label of a cannabis derivative product may include a flavor name if it is not candy-like or a name that appeals to children.
18	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (12)	The label of a cannabis product that contains an artificially derived cannabinoid shall clearly display the following text: "This product contains artificially derived cannabinoids."
19	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (13)	Any terpene listed on a cannabis product package shall be verified as present by a licensed independent cannabis testing laboratory and have its quantity listed on the fact panel.
20	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (14)(a)	A cannabis processing facility may include a logo and product brand name on the cannabis product face that is exempt from the requirements of Subsection R66-2-13(5) and that: (a) does not obscure the information required on the label;
21	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (14)(b)	(b) does not include: (i) terms, slang, phrasing, or verbiage associated with the recreational use of cannabis; (ii) any image bearing resemblance to a cartoon character or fictional character whose target audience is children or minors; (iii) content, symbol, or imagery that appeals to children; (iv) imagery featuring a person using the product in any way; (v) any recreationally oriented subject; or (vi) any statement, design, or representation, picture, or illustration that is obscene, sexual, or criminal.
22	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (15)	(a) No other information, illustration, or depiction with the exception of directions for use or an item required by state law shall appear on the labeling. (b) Any warnings required in Chapter 4-41a may be added to the label of any product.
23	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (16)	Shapes on cannabis product packaging or labeling may not resemble the product or real-world items.

24	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (17)	Labeling may not contain medical claims.
25	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (18)	Cannabis product packaging, logos, and brand names shall be pre-approved by the department.
26	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (19)	The department reserves the right to deny any label, logo, or brand name if the department reasonably believes it is in conflict with Chapter 4-41a or this section.

2	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (7)(b)	The cannabis fact panel for cannabis plant product shall include the following information, from top to bottom, in the order as listed: (b) the lot number;
3	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product.(7)(c)	The cannabis fact panel for cannabis plant product shall include the following information, from top to bottom, in the order as listed: (c) the date of harvest;

2	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (9)(b)	The cannabis fact panel for cannabis derivative product shall include the following information, from top to bottom, in the order listed: (b) the date of the final testing;
3	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (9)(c)	The cannabis fact panel for cannabis derivative product shall include the following information, from top to bottom, in the order listed: (c) the date on which the product was packaged;
4	R66-2-13. Labeling and Packaging of Cannabis and Cannabis Product. (9)(d)	The cannabis fact panel for cannabis derivative product shall include the following information, from top to bottom, in the order listed: (d) for products intended to be ingested, the amount of total THC and any advertised cannabinoid in milligrams per serving;

(9)(j)	The cannabis fact panel for cannabis derivative product shall include the following information, from top to bottom, in the order listed: (j) the net weight of the product displayed in grams or milliliters and number of pieces, if applicable;

(9)(k)	The cannabis fact panel for cannabis derivative product shall include the following information, from top to bottom, in the order listed: (k) a disclosure of the type of extraction process used and any solvent, gas, or other chemical used in the extraction process.

4-41a statute

1	4-41a-702. Reporting -- Inspections -- Seizure by the department.(3)	If an independent cannabis testing laboratory determines that the results of a lab test indicate that the cannabinoid content of a cannabis or cannabis product batch diverges more than 10% from the amounts the label indicates, the cannabis processing facility may not sell the cannabis or cannabis product batch unless the facility replaces the incorrect label with a label that correctly indicates the cannabinoid content.
2	4-41a-502. Cannabis -- Labeling and child-resistant packaging.(1)	For any cannabis that a cannabis cultivation facility cultivates or otherwise produces and subsequently ships to another cannabis production establishment, the facility shall: (a) label the cannabis with a label that has a unique batch identification number that is connected to the inventory control system; and (b) package the cannabis in a container that is: (i) tamper evident; and (ii) not appealing to children.
3	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(i)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (i) clearly and unambiguously states that the cannabis product or package contains cannabis;

4	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(ii)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (ii) clearly displays the amount of total composite tetrahydrocannabinol, cannabidiol, and any known cannabinoid that is greater than 1% of the total cannabinoids contained in the cannabis or cannabis product as determined under Subsection 4-41a-701(4);
5	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(iii)(A)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (iii) has a unique identification number that: (A) is connected to the inventory control system; a
6	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(iii)(B)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (iii) has a unique identification number that: (B) identifies the unique cannabis product manufacturing process the cannabis processing facility used to manufacture the cannabis product;
7	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(iv)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (iv) identifies the cannabinoid extraction process that the cannabis processing facility used to create the cannabis product;
8	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(v)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (v) does not display an image, word, or phrase that the facility knows or should know appeals to children;
9	4-41a-602. Cannabis product -- Labeling and child-resistant packaging.(1)(a)(vi)	For any cannabis product that a cannabis processing facility processes or produces and for any raw cannabis that the facility packages, the facility shall: (a) label the cannabis or cannabis product with a label that: (vi) discloses each active or potentially active ingredient, in order of prominence, and possible allergen;
